We, the undersigned residents of BLAIR HILLS 1) on or adjacent to Lenawee Avenue; and 2) on or adjacent to Wrightcrest Drive east of Lenawee Avenue, represented for this Petition by _____, (310)_____, e-mail address _____, who resides at _____ and is a resident of the subject neighborhood. Our neighborhood has a Neighborhood Association, and the representative listed above is in coordination with the Association's board. We, collectively, do hereby request that the City of Culver City complete the necessary Speed Surveys and Traffic Volume Counts to quantify our speeding problems on Lenawee Avenue. However, we request that such data not be used to determine if traffic calming features are considered, but rather, presented to the City Council to inform their decision. Additionally, we request that speed-calming measures, as collaboratively determined by the residents of the above-stated area and the City, be presented to the City Council for their consideration.

We understand that other streets in the neighborhood may be notified and invited to give input/participate in any public meetings, due to possible traffic impacts from potential traffic calming measures on Lenawee Avenue. Also, we understand that this Petition shall contain a minimum consensus representing Lenawee Avenue residents' desire for the speed survey, traffic counts, and for traffic calming measures. The minimum representation necessary is 75% of all the households within the above-indicated boundary. Additionally, we understand that funding for any future traffic calming features depends on availability of funds as approved by the City Council.
